

ERASMUS STUDENT NETWORK ELTE WELCOME WEEKEND 2018 SPRING

TERMS AND CONDITIONS OF PARTICIPATION

PREAMBLE

The aim of ESN ELTE's Welcome Weekend 2018 Spring (later on: Welcome Weekend) is to provide a platform of international and exchange students studying at ELTE to meet each other, learn about the culture of Hungary and to experience the natural beauty of the country. Participants also meet members of Erasmus Student Network (ESN) of their higher educational institution (HEI), therefore their integration to the network of local students is facilitated.

1. GENERAL PROVISIONS

- 1.1 The statements in the Terms and Conditions of Participation of Welcome Weekend (later on. Terms and Conditions) are obligatory for every participant of the Welcome Weekend, especially the exchange and international students studying in Hungary, the organizer staff of Welcome Weekend and hired staff (e.g. transportation service, hotel staff) of Welcome Weekend.
- 1.2 The statements in the Terms and Conditions are in force during Welcome Weekend

2. Conditions of participation in Welcome Weekend

- **2.1** Welcome Weekend is a closed event, therefore the organizers have the right to select participants of the Welcome Weekend
- **2.2** Participants selected belong to one of the following categories
 - a) member of the organizing committee (OC)
 - b) hired staff
 - c) visitor or guest (with the provisional approval of the OC)
- **2.3** Participants are entitled to participate in the event after the payment of the participation fee upon showing the proof of payment.
- **2.4** Organizers are obliged to provide participants listed in points 2.1-2.2 with a non-removable wristband at the beginning of Welcome Weekend.
- **2.5** Upon arrival participants should identify themselves with the ID card/passport they used during the online registration.

3. Rights and Obligations of Participants

3.1 The Head(s) of the Organizing Committee is/are the responsible person(s) for the coordination of Welcome Weekend

- **3.2** Every participant of the Welcome Weekend is obliged to keep the laws of Hungary and the regulations of their respective HEI. The Organizers cannot be held responsible if any of the Participants act against the laws and regulations. All participants are obliged to keep the contents of the Terms and Conditions and, in case of emergency, the instructions of the Head of the OC.
- **3.3** Participants are obliged to wear the identifier described in 2.4 in order to be identifiable as Participant.
- **3.4** It is forbidden to carry items prohibited by the current legislation to the event area. This includes but is not restricted to the following: guns, knives and blades longer than 8 cm, maulers, and any kind of pyrotechnical instruments. For detailed information see Government degree no. 175./2003. (X.28.)
- **3.5** It is forbidden to carry and use illegal drugs of any amount in Welcome Weekend (as is in the area of Hungary).
- **3.6** Participants are obliged to report their acute or chronic diseases (including allergies that may lead to life threatening situations) to the organizers and is obliged to give a description of the medications used to treat the condition.
- **3.7** As participants have the right to enjoy Welcome Weekend in a disease free environment, persons with contagious diseases cannot enter the event area and the organizers have the right to remove such persons from the participants' list. If any participants experience fever on themselves or gain knowledge of any participant with fever, they should report this to the organizers immediately.
- **3.8** In case of accident resulting in physical damage of the Participants, the organizing committee of the event should be notified immediately. If necessary, the organizing committee will call the ambulance.
- **3.9** In case of medical emergency (a serious, potentially life threatening event) the ambulance and the organizers should be notified immediately. The phone number of ambulance is 104. (no country code needed)
- **3.10** Smoking is allowed in the designated areas only.
- **3.11** Starting a fire is strictly prohibited in the camp area.
- **3.12** In case of a fire event the organizers should be notified and firefighting should be started. If necessary, the fire service should be notified as well (phone number: 105)
- **3.13** Every participant is obliged to protect the natural values of the event areas. Participants are also obliged to protect the built and manufactured surroundings of the event areas, as well as the furniture and other items provided.
- **3.14** Participants bring their valuables to the event to the participants' liability, the Organizers or the accommodation owners do not take any responsibility for the loss of the valuables (including but not restricted to mobile phones, notebooks, wallets, money).
- **3.15** Participants and Organizers are responsible for the cleanness of the event areas. Garbage should be placed in the designated areas only.



3.16 Pictures may be taken and video may be recorded during the event. However, people seen in these photos and recordings are not entitled to raise any financial or moral demands towards the organizers.

4. CONSEQUENCES OF VIOLATIONS OF THE TERMS AND CONDITIONS

- **4.1** If any of the Participants violates the Terms and Conditions, the Main Organizer may take any of the following decisions:
 - a) admonishing the Participant
 - b) withdrawing the Participant's right to further participate in the event
- **4.2** The Main Organizer, depending on the severity of the infringement, has the right to contact the legal authorities and initiate the prosecution of the Violator
- **4.3** The Violators do not have the right to raise any financial or moral demand towards the Organizers.

5. REFUND POLICY

- **5.1** If any of the Participants wish to cancel their reservation for the Welcome Weekend it is possible with the conditions below:
- **5.2** Participant will get the whole amount of attendance fee back if the Treasurer of the ESN ELTE is informed in email, more than 72 hours before the departure. (treasurer@esnelte.hu)
- **5.3** Participant will get 50% of the attendance fee back if the Treasurer of ESN ELTE is informed in email, less than 72 hours, but more than 24 hours before the departure. (treasurer@esnelte.hu)
- **5.4** Participant will not get back any of the attendance fee if the Treasurer of ESN ELTE is informed less than 24 hours before the departure.
